# Challenges in Confronting Racial Discrimination in Angie Thomas's Novel 'The Hate U Give'

#### Abstract

This study aims to find out how racial discrimination and its impact can occur on African-Americans as reflected in the novel entitled The Hate U Give by Angie Thomas (2017). Furthermore, this study analyzes how the struggle of African-Americans who live alongside with white people and how racial discrimination revealed due to racial differences where the black race is the weaker group, while the white race is the strong group with the privileges they have. The writer uses a descriptive qualitative approach in this study. The data collected are excerpts from dialogue novels to be analyzed using two theoretical books entitled Critical Race Theory by Richard Delgado and Jean Stefancic (2001) in analyzing racial discrimination and African-American struggles, then Theory of Racial and Racism (2000) by Les Back and John Solomos in analyzing the impact of racial discrimination. ## C. Findings and Discussion

#### 1. Racism Revealed in The Hate U Give's Novel

In the novel *The Hate U Give*, Starr Carter defends her friend, Khalil, who became a victim of murder by a white police officer without committing a crime, the thoughts of racism and racial discrimination are still happening today in the world. White people oppress black people, they believe that they have great privileges, hence, they are happy to do negative things like racism and discrimination also spread hatred toward black people. African-Americans have become objects of discrimination in American history and become people in a black concept where white people make them an exception in the scope of society that has been embedded in American history, namely discrimination and prejudice against African-Americans (Delgano and Stefancic, 2001, p. 69). According to Delgado and Stefancic (2001), the concept of Power and the Shape of Knowledge can be related to the quotation of *The Hate U Give* story when the police have a prejudice against Khalil and Starr, the white police officer checks Khalil's car which is parked on the side of the road which in reality they just want to go home and talking for a while.

Starr did this to prove that not all black people are different; they also have the same equality as white people. Black people also deserve a good education and think more broadly like the parenting done by Starr's parents, Maverick and Lisa. Like most teenagers, Starr came to the party in her town, Garden Heights, she also had to get used to the flesh and blood of her ancestors. Starr meets up with her friends, especially Khalil and Kenya, she tells Starr that her habits are different because she's used to a white group, but it's not. While Starr and Khalil were enjoying the party, suddenly an explosion was heard in the distance. They panicked and immediately saved themselves. This illustrates the act of discrimination reflected in the novel.

The crowd stampedes toward the door, which leads to more cussing and fighting since it's impossible for everybody to get out at once. —Khalil grabs my hand. "C'mon." There are way too many people and way too much curly hair for me to catch a glimpse of Kenya. "But Kenya—" "Forget her, let's go!"—

"Always some shit," he mumbles. "Can't have a party without somebody getting shot." (Thomas 2017, p. 11-12)

## 2. The Impact of Racial Discrimination Towards The Main Character in The Hate U Give novel

As the novel tells about Starr's personality as the main character, she is a brave girl, she always ignores the things which can make her be bullied. The stereotype, prejudice, and racism she can face with her happy smile. Starr is very wise to make the decision, because of that she rarely feels annoyed by other people who see her as a black person. but the situation has changed when Khalil died. It was a big hurt for Starr until she must receive the impact of the racial discrimination action which makes her psychologically destroyed and it gives the huge trauma for her.

The discrimination action that was experienced by Starr as the main character always stick tight in her mind. She is flashing back to the time when Natasha was killed. The shot happened when the attackers came and then shot Natasha twice and it made her unsafe. This reflection of Natasha's tragedy comes back after Khalil was killed too by the brutal cop, and it makes Starr traumatized and affect her social behavior. Because of that, the trauma experienced by Starr makes her feel down and depressed because of Khalil's departure. The impact of racism in this modernity still gives the tensions and traumas for those minority races who being discriminated (Back and Solomos 2000. p. 224-225).

Starr felt that the parties who interfered in the killing of Khalil were not defending Khalil but were cornering Starr. Such racism still exists when truly wrong conditions cannot be punished, such as the killing of Khalil by racist police. Black people's rights were always restricted and they had no right to justice and were forced into silence. Delgado and Stefancic state that the privilege of black or brown people cannot be supported. The privilege does not apply to black people who if they kill a white person the penalty is 10 times greater (2001, p. 110-111).

I mean, anytime he finds out a black person is with a white person, suddenly something's wrong with them. I don't want him looking at me like that.

Luckily, Momma hasn't told him. She refuses to get in the middle of that fight. (Thomas, p. 23)

### 3. The Main Character Struggles Against Racial Discrimination

The Hate U Give novel by Angie Thomas represents African Americans Struggles. The novel's story highlights how their struggle to get their rights, life survive as a minority race, often feel insecure because there is so much that white people do to do racism and discrimination. African-Americans live above the perspective and prejudice that makes them feel unfree lives. Starr Carter as the main character describes African-Americans which mean that although she is a teenager the

writer gives a brave characterization to her to imagine how African-American's struggles are revealed.

Starr Carter's struggles depict the movement of Black Lives Matter which aims to get equal rights as white people. There are so many troubles for Starr, she has to forget the event when she saw Khalil's body full of blood because of the shooting until he died. The united states are full of racist perspectives towards African-Americans and they have a big power to maintain their interest, especially their rights. ...The other talk was about what to do if a cop stopped me. Momma fussed and told Daddy I was too young for that. He argued that I wasn't too young to get arrested or shot.

"Starr-Starr, you do whatever they tell you to do," he said. "Keep your hands visible. Don't make any sudden moves. Only speak when they speak to you." (Thomas 2017, p. 14)

#### **D.** Conclusion

In this study, the writer summarizes that the discrimination experienced by African-Americans is because it is inherent in the history of them as immigrants. African-Americans are a low-class minority who do not have the power to fight for their rights as black people who are considered criminals and drug dealers which affect their social activity. Racial discrimination still occurs because of the differences power race that revealed in The Hate U Give novel, the minorities are difficult in achieve their rights and equal humanity treat. The impact of racism influences African-Americans mentally and physically as a minority race, especially toward Starr Carter as the main character.
