According to Spivak's quote above, hard to apply the great theorizes through the transition from feudalism to capitalism differentiation among social arise the variation opinion, that is why political itself is the part of subaltern as Spivak says. Based on the book of Gayatri C. Spivak subaltern is At this time the relationship between subaltern and feminism is very close, both of which discuss women specifically and in detail, for example, every time we discuss the subject of subalterns against women we will indirectly discuss the problem of feminism in it too, such as when the subaltern occurs in a princess who will marry a prince for political purposes. In this case, it is clear that women who cannot fight for their rights are a form of subaltern and the princess is a depiction of women whose rights are shackled by subatern, and that is what every feminist wants to fight for. So cleary expalin relationship about feminism and subaltern are very close. Based on the background namely in societies where men are the main power holders who dominate the role of leaders which is called patriarchy between patriarchy and imperialism, subject-constitution and object formation, the figure of the women disappears, not into pristine nothingness (Spivak, 1985, p. 102) above, it can be conclude that the subaltern is a theory aimed at the oppressed in that women who are considered inferior do not have rights over themselves or it can be said that a woman's destiny has been determined since she was born. Even in normal society women have been categorized as subalterns as the explains in the book can the subaltern speak (Spivak,1985, p. 74), namely in societies where men are the main power holders who dominate the role of leaders which is called patriarchy between patriarchy and imperialism, subject-constitution and object-formation, the figure of the women disappears, not into pristine nothingness, but into a violent shuttling which is the displaced figuration of the 'third-world woman' caught between tradition and modernization (Spivak, 1985, p. 102). The quotes above is explain "patriarchy is a system structure social and practice which positions men, as the dominate, oppresses, and exploits women" (Walby, S., & Towers, J. 2018).

The portrayed of Lei in our real life is that she is a prostitute who has an obligation to obey those who have paid for her. The present research paper tries to find out how the term subaltern is applicable in Indian context and how the select novel expresses the voices of subaltern. It states a hope both for the untouchable Hindus and India, bringing the philosophy of Gandhi which efforts to raise consciousness with the purpose of removing the caste system as well as hierarchical system of the Indian culture. Issue subaltern with the background Hindus and India as the target this journal related to the subaltern by Spivak and of course the writer wants to show how the role of caste in India are related to the subaltern.

The second study was done by Artanti, S. K. (2019) from State University of Surabaya with the title, "*Sea of Poppies*" by Amitha Ghosh. He uses the postcolonialism theory by Homi K. Bhabha (2011). This study has the similarity meaning with the subaltern by Gayatri C. Spivak, overall, the expectations that theoretical productions will finally affect how is subalternity represented in *Sea of Poppies*? How do Indian Women's struggle to fight against patriarchy in Sea of Poppies by Amitav Ghosh? The results of this study show that Subaltern represented by Indian Women. Then the struggle of Deeti as an Indian Woman and the other characters fights against the arrogance and vanity.

And the last study was done by Megawati (2017) "Subaltern Portrayals in the Hunger Games: Mockingjay Part 1 Movie" from UIN Alaudin Makasar the theory used in this thesis was Gramsci's (1929 and 1935) Concept of Subaltern theory. The writer aimed to discuss about social and political aspect in the The Hunger Games: Mockingjay Part 1 Movie, using the theory of subaltern the writer wants to present social level and how the world affects in the movie the hunger games: Mokingjay part 1 is related to the subaltern.

Based on of all the studies above, this study has a related object of the study. The previous studies have the same object and limited analyze by the narrative elements and subaltern. Since a story in this novel is using the narrative elements such as character, plot, point of view, setting, and theme were used in this study; along with the narrative and subaltern. All of the element were used to elaborate and analyze the object which the deeper aspect in the novel to reveal the issue from the studies the wants to analyze.

The oppression of women clearly described by Spivak in his book. Spivak emphasizes the importance of looking at the unconscious mechanism of hegemony, regarding the use of subaltern word attributes in labeling someone from the lower class and even from minority. They are in a hegemonic discourse which means there is some kind of unconscious manipulation of what they are doing (de Kock, 1992). The unconscious oppression that the royal soldiers do against people who are subalternized, is a hegemonic mechanism that occurs in the Ikhara community, Lei and the other girls have considered what happened to them as fate that they must accept and have to live because of it. is a must or it will become a black smudge in their future life, in other words they have no choice but to follow and accept what has been destined for them.

In the book *Girls of Paper and Fire*, the subaltern is represented by Lei as the main character, her mother, and seven of her friends. Not only that, Subaltern also lives under the patriarchy, and the subject is fighting the social patriarchy as the target of subaltern. As the Gayatri says "for if in the context of colonial production, the subaltern has no history and cannot speak, the subaltern as female is even more deeply in shadow" (Spivak, 1985, p. 27). She cannot speak to anyone much less against the life of a woman who is subalternized like living in a shadow like Lei said is refers to casted in the novel *girls of paper and fire* "cursed years to be played out in the fire and shadow" (Ngan, 2018, Casted). What has been said before are kinds of subaltern what happens to Lei have been explains by Spivak.
